The slogan "Milliy tiklanishdan - Milliy yuksalish sari" ("From National Revival to National Prosperity") is a call for the goal to make Uzbekistan a powerful state and the citizens of Uzbekistan a prosperous nation.

The Democratic Party of Uzbekistan "Milliy tiklanish" sets the following main goals and objectives:

- active participating in reforms aimed at building a new Uzbekistan with the idea of "Changing society by changing people" based on the slogan "From national revival to national prosperity";
- modernizing of the country to achieve spiritual and social development, creating conditions for the development of human capital;
- transforming Uzbekistan into a developed modern state, further promotion of international authority and prestige;
 - providing the priority of national interests in all areas;
- preserving national, cultural, spiritual wealth, rich historical heritage, customs, traditions and values of the nation of Uzbekistan;
- uniting the patriotic people who deeply respect the cultural, traditional and national spiritual values of the nation of Uzbekistan;
 - ensuring the harmony of national and cultural values and modern progress;
- ensuring the rule of law by increasing the legal, political consciousness and culture in society;
- providing the reliable communication of the state and society, accountability of officials to citizens and ensuring the effective use of citizens' rights in public administration.

We consider one of the important tasks the realization of the aspirations of our electorate, its comprehensive support, protection of rights and freedom, legitimate interests.

Our party, as a political force in the country, is on the path to get decisive positions in all representative bodies, nominating a candidate for prime minister, initiating bills consistent with the ideas of the party through its faction in the Legislative Chamber of the Oliy Majlis, supporting candidates recommended for government members based on their programs.

I. Priority areas for the further democratization of government and administration, the formation of a spiritually harmonious civil society

"DIALOGUE OF THE STATE AND PEOPLE— MILESTONE OF PROSPERITY"

We consider Uzbekistan as a politically powerful country with a rich spiritual and educational heritage, an economically developed, stable civil society, guaranteed human rights and freedom.

The party believes that the moral and material improvement of our nation, which is the main source of achieving these goals. The party is a supporter of increasing efficiency, ensuring openness and transparency of public administration, boosting long-term development strategies, introducing innovations in the activities of government bodies, as well as further improving the system of training, retraining and advanced training of staff for public administration.

Establishing a constant and systematic relationship with society, ensuring close interaction between the state and citizens, taking into account the fact that the activities of the branches of government are based on the principle of "people should not serve the authority, but the authority should serve the people", is based on establishing effective public control over the activities of government bodies.

The party considers its main task to ensure in practice the implementation of the principle "to make the parliament the "People's House", and to make deputies true representatives of our people". The party takes measures to study, analyze and search for solutions to the problems of our people by establishing, first of all, constant and continuous contact of deputies elected to the Legislative Chamber of the Oliy Majlis and local Kengashes with their voters.

1.1. In the field of increasing the role of the Oliy Majlis in the system of state government, as well as the role of political parties and other civil society institutions in the life of the society and state:

- the establishment of more fruitful relations between the chambers of the Oliy Majlis, executive and judicial authorities;
- development of international cooperation between the chambers of the Oliy Majlis, in particular, the establishment of continuous relations with foreign parliaments and international parliamentary organizations;
- incorporating and implementing "the concept of people's diplomacy" and "the concept of parliamentary diplomacy";

- widening the power of the Oliy Majlis to exercise control over the activities of the government, in particular, the introduction of "electronic parliament", "electronic parliamentary control", "portal of parliamentary control";
- providing an active participation of political parties and other institutions of civil society in the process of building society and the state;
- the introduction of modern mechanisms for the wide involvement of citizens in the development of regional and state projects;
- the introduction of a system of compulsory submission and acceptance of proposals for the consideration of draft state and territorial programs to deputies of all levels, as well as the Legislative Chamber of the Oliy Majlis and regional, city Council's deputies;
- introduction of the practice of sending draft regulatory acts developed by the Cabinet of Ministers, ministries, government bodies and departments, political parties, in order to analyze depending on their specifics;
- introduction of a system of sociological studies of the effectiveness of adopted laws, as well as their social, economic, political, legal consequences;
- expansion of participation in international ratings for state and public administration, in particular, wide participation in ratings of trust in public policy.

1.2. In the field of developing people's power, strengthening public control, improving the activities of local councils of people's deputies:

- taking measures to ensure in practice the constitutional principle according to which "the people are the only source of state power";
- increasing the role of local council's deputies in the system of local state power, stating their obligations and role exactly;
- further expansion of the control powers of local council's deputies over local executive bodies, in particular, strengthening the accountability of local executive bodies to the deputies of local councils;
- introduction of the practice of passing discussions by local councils of people's deputies before being appointed as heads of local executive bodies, with responsibilities of candidates to represent their medium-term and long-term programs with clear indicators;
- strengthening the activities of deputies and party groups in local councils in order to take efficient control over local executive bodies, as well as increasing the legal status of the chairmans of the local councils to establish strict deputy and public control over the activities of the local executive bodies;
- phased abolition abolish the system that the head of the local executive body is simultaneously the chairman of the local council of people's deputies;

- creating a clear system to make deputies of representative bodies at all levels of the party work in continuous cooperation.

1.3. In the field of further reform of public administration and public service:

- strengthening the status of state workers at the legislative level, introducing a system for selecting state workers based on the requirements for knowledge, qualifications, abilities and enrichments, forming a reserve of young national cadres, ensuring a "social elevator" through their systematic presentation to the civil service;
- introducing the system for evaluating the performance of all state organizations and employees;
 - creating a model for the promotions of state workers into official positions;
- widespread introduction of interdepartmental rotation of workers, as well as internal rotation in the organization;
- supporting for reforms that enhance the openness of government and management, accountability of government bodies and leaders for society and people;
- eliminating administrative bureaucracy, meeting without special need by central bodies of state administration to local authorities and executive bodies, while ensuring their independence and increasing their responsibility;
- increasing the effectiveness of protecting the rights and legitimate interests of citizens by creating an effective system of communication between state bodies and citizens:
- creating a healthy spiritual environment and ideological immunity in the activities of state bodies and their officials, ensuring the rule of law, improving the legal awareness and culture of workers;
- providing citizens with access to detailed and open information about the activities of state bodies, thereby further strengthening confidence in the state;
- the establishment of social protection of state workers, the protection of their rights, the expansion of the system of material incentives, while increasing their social responsibility;
- conducting objective sociological research aimed at studying, analyzing the needs, requests and desires of citizens.
- 1.4. In the field of further increasing the status of the Uzbek language as a state language, in the matter of its wide promotion in our country and abroad:
- enrichment and further improvement of the state language, the development of a set of measures aimed at improving the culture of the language, the quality of

mutual circulation, carrying out specific and focused work that will prevent violations of the norms of the Uzbek language in official and public circulation;

- The adoption of practical measures to ensure the development of the Uzbek language, its purity, ease of use, ease of use;
- the use of the state language in government bodies and in government and in official circles, as well as the writing of legislative acts and departmental correspondence only in the state language;
- creating conditions for learning the Uzbek language both domestically and abroad, including assistance in creating free online platforms aimed at teaching the Uzbek language;
- supporting for expanding the database of the Uzbek language, including translation of practical and professional books in foreign languages into the Uzbek language;
- providing necessary materials to meet the demands of our compatriots living outside of Uzbekistan for the Uzbek language and culture;
- ensuring the use of the state language in the media, in particular on television, radio and in the streets for advertising and other external announcements;
- annual holding of competitions in the Uzbek language among the general public members and state workers;
- conducting ongoing activities to teach and to popularize the Uzbek language in foreign countries where our compatriots live;
- improving the quality of the dictionaries of the Uzbek language, stimulating the creation of electronic programs in the Uzbek language and their practical applications;
- creating a national Internet search system in Uzbek, an increase in the number of open Internet sites containing scientific and educational resources in the Uzbek language;
- teaching the Uzbek language as a foreign language internationally, first of all, promoting the popularization of methods based on modern multimedia tools that contribute to the study of the Uzbek language in an easy way by other nationalities living in Uzbekistan;
- The creation of the Scientific Translation Center at the Department of the State Language Development in the structure of the Cabinet of Ministers of the Republic of Uzbekistan;
 - Strengthening responsibility for violation of the Law on the State Language.

II. Priority areas for ensuring the rule of law in the country and further reforms of the judicial system.

"ACHIEVEMENT OF THE WELFARE OF THE PEOPLE AND THE DEVELOPMENT OF THE STATE BY TIMELY MAKING AMENDMENTS AND ADDITIONS TO LEGISLATIVE ACTS, ALSO BY MEANS OF ENSURING THE FULL IMPLEMENTATION LEGISLATION IN PRACTICE"

Ensuring the rule of law and further reforming the judicial system, strengthening guarantees of genuine independence of the judiciary and reliable protection of the rights of citizens is a priority for our society.

Accelerating the formation of a democratic society and the success of reforms in this area mainly dependent on the legal consciousness and legal culture of the citizens. The party considers one of its main tasks to increase the legal awareness and culture of citizens, which are the basis of a democratic society and an indicator of the perfection of the legal system in the judicial sphere.

The party carries out systematic approaches to ensure enforcement of the rule of law, including the protection of human rights and freedom, the inviolability of private property, the enforcement of laws in practice, and the elimination of conflicting or repeating norms in legislation.

The party considers supporting to increase legal and political intellect of citizens as its important function in the judicial sphere. Our party welcomes the adoption of systemic measures aimed at further improvements in legal education within the country, promoting legal knowledge in society.

The party aims to improve the legal framework aimed at limiting unreasonable interference of state authorities and management in the activities of private entrepreneurship.

The party takes an active part in achieving direct implementation of laws, that is, in the process of minimizing reference standards in laws and reducing the number of regulatory legal acts.

2.1. In the field of further improvements in the activities of the judiciary and law execution organizations, promoting the concept of "Sustainable Legislation":

- establishing systemic measures aimed at further improving legal education, popularization of legal knowledge in society;

- increasing the effectiveness of public control over the activities of law enforcement agencies, strengthening the trust of citizens in the law enforcement system;
 - strengthening guarantees of of the citizens' rights for private property;
- ensuring mandatory liability for consideration of citizens' appeals, providing responsibility not to be careless, bureaucratic in the process of working with appeals.
- development of the institution of advocacy, raising the status and role of the advocate in criminal, administrative, civil and economic cases;
- ensuring equal rights of prosecutors and lawyers in the inquiry processes, pre-investigation checks directly in the trial;
- ensuring the horizontal and vertical independence of the judiciary and judges, ensuring that their monthly salary is not less than the monthly salary of employees of other bodies;
- a wide discussion on the transfer of organizations for the execution of sentences and their management to the Ministry of Justice or making them as an independent organizations;
- in case of liberalization of the judiciary, to improve the legal norms for observing the presumption of innocence, as well as to create clear legal mechanisms and norms restricting cases of declaring person's guilty in the media and social networks prior to the court's final decision, producing legal mechanisms not to be in a cruel attitude for citizens;
- ensuring the full independence of the High Judicial Council, ensure public participation in the formation of the judiciary, including the introduction of a system of public opinion in the selection and appointment of judges of district, city and regional courts;
- supporting for the participation of representatives of public organizations as public defenders in court cases of young people;
- ensuring the practical implementation of the "Sustainable Legislation" Concept, that is, introducing a system not to make unnecessary amendments and additions to legislative acts, preventing the enforcement of new legislative acts without clear necessities, as well as transition to the practice of adopting legislation being in the usage for many years;
- the establishment of specific criteria for the acceptance of secondary legislation.

2.2. In the field of increasing the legal, political consciousness and culture of the population, uncompromising fight against corruption:

- the transformation of legal, political consciousness and culture into an integral part of universal culture;
- putting forward initiatives to create a system of providing free legal aid to people in need online or in another form by state and private organizations, to organize public associations such as the "Civil Advisory Council", implementing a project called "The Best Legal Charity of the Year";
- formulating measures to make every citizen know the law and apply it without a doubt;
- the creation of mechanisms aimed at attracting families, educational institutions, makhalla institutions, government institutions to the formation of lawabiding citizens;
- ensuring a high level of direct and indirect participation of our nation in the political processes;
- expanding the active participation of the population in the discussion of law projects, secondary legislation and other regulatory legal acts;
- producing spiritual and educational methods and ensuring the inevitability of responsibility in the fight against corruption, the formation of an uncompromising attitude towards corruption in the minds of people.

2.3. In the field of introducing such noble qualities as mercy, generosity, compassion, humanity and tolerance into judicial practice:

- further liberalization of legislation on criminal matters, simplification of the policy of decriminalization of certain crimes and the procedure for the execution of criminal sentences;
- the establishment of administrative and criminal liability for monopolistic activities, as well as for violations in the field of medicine, in particular, the failure to provide medical care, the provision of incorrect information in the diagnosis and treatment, and other cases;
- widespread introduction of the institution of reconciliation in administrative cases in the process of courts;
- the implementation of modern institutes of criminal law into the national legislation, which are widely used in international practice, in particular, the expansion of the category of criminal cases that are instituted only with the application of the victim;
- improving the system of pre-court settlement of family, inheritance, housing claims and other conflicts arising in everyday life, including the desire to reach a compromise and the peaceful resolution of any dispute, which is inherent in our

people, reducing the proportion of cases considered in court, in practice, by widespread use of pre-court institutes;

- Association of criminal, administrative, civil and economic courts operating in districts, cities and regions, while maintaining the specialization of courts.

2.4. In the field of improving the lawmaking process and ensuring the rule of law:

- establishing the legislative framework for legal expertise and anti-corruption expertise of legislative projects;
- ensuring the adoption of direct applicable laws, reduction of secondary laws and regulatory acts, as well as minimizing the adoption of regulatory acts by the Ministries, government bodies and departments and phasing out this practice;
- the establishment in the legislative procedure of participation not of deputies, but of officials or responsible representatives of entities having the right of legislative initiative as a speaker in the adoption of bills in the first reading in the Legislative Chamber of the Oliv Majlis and discussion in factions;
- unification of legislation in the field of economics, trade, industry, energy, healthcare, tourism, logistics, transport, aviation with international standards and legislation of developed foreign countries with the aim of introducing modern approaches to the lawmaking process;
- creation of an electronic system for coordinating legislative projects with interested organizations;
- improving existing procedures for promoting legislative initiative, focusing on the fact that the initiative is aimed at solving the problems of the people and is based on relevant scientific approaches and specific social surveys;
- announcing bills for public, a comprehensive learning of proposals and comments.

III. The priorities for developing national economy

"IF THE NATION IS RICH, THE COUNTRY WILL ALSO BE RICH AND POWERFUL"

The party's priority is to create a strong, stable and competitive economy. The party believes that an individual approach should always be provided for in economic relations.

The party supports an increase in the middle class in the country and serves to promote qualities such as satisfaction and gratitude in the middle class, recognition of responsibility and spiritual values among the rich. The party is a supporter of reducing the level of income stratification, increasing real incomes and purchasing power of the population.

The party advocates reforms aimed at drastically reducing state participation in the economy and protecting private property, and for ensuring the activities of business structures that are not subject to unlawful interference.

The party considers the sustainable penetration of our national products and brands into foreign potential markets as a vital necessity.

The party stands for effective support of local producers and services in our country, support for an active foreign economic strategy of Uzbekistan based on national interests. We are actively working to increase the reputation of the national brand "Made in Uzbekistan" in the world market.

At the same time, the party considers it is necessary to develop a system to make products manufactured in Uzbekistan more attractive to our consumers.

Tourism plays an important role as a factor accelerating the process of economic development. High development of the tourism industry will contribute to the creation of additional jobs, increase employment of the economically active population, increase the welfare of the nation and promote our national, cultural and spiritual values in the world. It will give impetus to the development of a number of interconnected sectors of economic sector, in particular, infrastructure, and will contribute to their further popularization.

The party supports measures to capitalize intellectual property by modernizing the technological base, research and development, stimulating investments, commercializing their results, budgetary, tax and other means of stimulation.

We are for improving the investment climate in the country's economy. Investments should flow into our economy primarily through legislative guarantees.

It is necessary to reduce the differences in the level of socio-economic development of the regions, to improve the regulatory framework for the formation and distribution of the local budget.

The party believes that simplifying the tax system in the economy, improving tax administration, ensuring the stability of the state budget, increasing freedom in the formation of local budget revenues, ensuring moderation of state budget expenditures and budget deficits, containing inflation and increasing the sensitivity of monetary policy instruments will give a serious impetus to the development of the economy.

The party supports the creation of a competitive national financial system, stimulation of direct investors, the abolition of value added tax and income tax for certain types of products (goods, services), the introduction of modern market mechanisms in the banking and financial system, and the promotion of public confidence in its guarantee.

3.1. In the field of increasing the competitiveness among local manufacturers and service providers:

- the formation of a system that promotes and propagates the consumption of products under the brand name "Made in Uzbekistan";
- supporting in all respects of domestic manufacturers who replace foreign products and produce commodities demanded in abroad;
- technical and technological modernization of production, reduction of nontarget production costs, introduction of new, modern technologies;
- mutual harmonious development of the capital and regions, cities and villages of our country, the elimination of some discrepancies in the economic and social development of the regions;
- meeting the needs of our people, especially young people, in modern highquality clothing made directly in our homeland, increasing the number of mobile and compact textile enterprises;
- the introduction of a simple and convenient licensing system in the manufacturing sector;
- creating of a legal framework to protect the national market from low quality products and services that are incompatible with international standards;
- increasing the share of private property in industry, transport, communications and other areas of production, as well as in the provision of services:
- the formation of confidence among our people in products created by local manufacturers.

3.2. In the field of development of high-tech and basic industries leading in the country's economy:

- developing the infrastructure which is necessary for the national economy, including railways and roads, improving the quality of energy supply;
- incorporating payment system for energy use taking into account the level of incomes of the population in order to develop the energy infrastructure in the country and increase the energy efficiency of the economy, the development of the energy sector, including the development of the electric power industry, the oil and gas, nuclear energy sectors and the expansion of the use of alternative energy sources, as well as the implementation of reforms providing for the distribution of energy resources in the existing sales system;
- creating conditions for the efficient and free use of energy resources, available raw materials and resources, not only in the leading sectors of the country's economy, such as engineering, electrical engineering, light industry, but also in the services sector, attracting investment inflows into these areas;
- accelerating reforms aimed at localization of industry in our country, further development of industrial cooperation and production of high demand products;
- implementing reforms aimed at industrialization of agriculture, the introduction of agricultural infrastructure, new technologies in agriculture, including the technologies of "Smart Agriculture";
- increase the material benefits of producers in agriculture, as well as the implementation of measures aimed at the formation of private property.

3.3. In the field of national innovation system and technology development in the national economy:

- the widespread introduction of the "digital economy" in the national economy, the development in the country of the mechanism of the widespread transition to digital technologies;
 - providing our country with high-speed Internet;
- creating IT infrastructure for the rapid development of Internet commerce, electronic services, digital television and mobile Internet, distance learning, industrial Internet (3D printing) and BigData technologies in all sectors of the economy;
- the development of the unification and cooperation of relations between institutions, universities and industry in order to reduce technological backwardness in economic sectors;
- attracting specialists with a high level of technological knowledge, providing a wide range of opportunities for organizing enterprises and

organizations engaged in activities in the field of innovative developments (nanotechnology);

- support of innovative business and the expansion of demand for innovation in the economy, the development of a competitive environment in the field of technological competition and innovation;
- support for the creation and development of small and medium-sized innovative businesses, including the reduction of administrative barriers to the creation and development of innovative businesses, the study of the requirements for the transition of small and medium-sized businesses to innovative activities, thereby creating government orders for research and development.

3.4. In the field of supporting for domestic producers in the implementation of foreign economic activity, including export promotion:

- carrying out large-scale customs reforms, including reducing the number of procedures for conducting foreign economic activity, canceling a number of necessary documents (examination, certification);
- reducing inspections and control in foreign economic activity, simplification of communication or relations between entrepreneurs and customs officials;
- support of business entities involved in export promotion and the preparation of import-substituting products.

3.5. In the field of ensuring the stability of the national economy:

- announcement of a general tax amnesty for individuals and entrepreneurs for the period up to 2019;
- simplification of the tax system, the provision of freedom in the formation of local budget revenues, ensuring moderation of expenditures and the budget deficit of the state budget;
- the growth of domestic savings in the economy, credit and investment activity and sustainable development of the economy as a whole, the implementation of an effective monetary policy to control inflation;
- implementation of a legislative initiative aimed at introducing modern market instruments into the banking and financial system, including the introduction of lending instruments based on partnerships between banks and entrepreneurs as an alternative to the traditional financial system, which is currently rapidly developing in the world;
- the rapid development of the stock market and the capital market in the country, a radical reform of the national insurance system and the wide involvement and promotion of this sector in all sectors of the country's economy.

IV. Further development of the social sphere, as well as priority areas of fundamental reform of the education system in the country

"CONTINUOUS UPBRINGNING AND EDUCATION – THE FOUNDATION OF A STRONG SOCIETY AND STRONG STATE"

Improving the quality and standard of living of the population, improving living conditions are the main goals of the party in the social sphere.

The party supports innovation for the development of human capital, low costs and rapid development through a reliable training and education system.

The party believes that the education system is a milestone of educating young generation who is responsible and capable, free-thinking, self-respecting, faithful to national and universal values and the future of our country.

The party pays a great attention to create conditions for the education and job of females and males in conditions that take into account their specific needs, providing gender balance in the social, spiritual, economic, legal, political spheres, which serves to ensure democratic principles.

We believe that in order to improve the living and working conditions of women, it is necessary to amend the legislation, and we state that the family is the pillar of society, and the woman is the pillar of the family.

The party supports an effective system for solving existing problems by learning the social and moral environment in families, and conducting an active dialogue. The party supports of the preservation and strengthening of traditional family relations and family values.

The party is actively working on reforming the education and upbringing system in our country, and on improving its quality. In this case, we consider it is necessary to consistently improve these systems.

The new period that began in our country also sets clear and strict requirements for the education sector. The party considers the role of upbringing in the current education system is insufficient. The education and upbringing system, including the period "family - pre-school education - school", which is considered to be priority period for the formation of an educated, free-thinking, honest and responsible person who recognizes national and universal values. The effectiveness of the system might be reached by the comprehensive elimination of existing problems in the family, preschool institutions and schools.

The party advocates the introduction of the subject and the creation of the textbook "Tarbiya" ("Parenting"), which will be taught from grades 1 to 11, and also we support the increase in the number of hours of the Uzbek language and

literature lessons, the subject "History of Uzbekistan", which provide knowledge about the history and spiritual values of our nation .

Ensuring the healthy development of children through physical education in preschool institutions and schools should be considered as a matter of improving the national gene pool.

It is necessary to ensure transparency and facilitate the process of confirmation of diplomas received by citizens of our country in foreign educational institutions.

It is very important for us to improve the working and living conditions of scientists and teachers, as well as to increase the respect for them in society.

4.1. In the field of meeting the social needs of the population, improving the quality of life:

- improving the living standards of people, first of all, ensuring the prosperity and well-being of the rural population, increasing the culture of their life;
- supporting the construction of housing and infrastructure as a priority area of development, the allocation of long-term mortgage loans to young families, the construction of housing for them, and the promotion of further systematic continuation of the implementation of this system;
- usage of international best practices and national architectural traditions in construction and decoration, implementation of large projects aimed at the reconstruction of historic cities;
- improving the system of transport services for passengers, including residents of remote and rarely accessible areas of the country;
- creation of organizational and legal conditions aimed at employment of the electoral part of the population, primarily the development of craftsmanship, family entrepreneurship, home-based types of work among women and youth, ensuring their employment;
- the development of further plans for the development of traditional medicine and the adoption of legal measures aimed at bringing it to the level of modern medicine;
- cardinal reform of the drug trade system, improving its quality and lowering its price, including fixing the condition on legislative basis that sellers of medicines for state medical institutions should not be any business entities, but manufacturers or representatives of the product itself;
- making basic reforms in the medical and pharmaceutical sectors, increasing the position of medical prevention in health care, including reforms to improve the medical culture of the population;

- developing the primary preventive system of medicine, increasing material viability, social protection of workers serving in the primary preventive system of medicine;
- increasing budget funds allocated for the development of cultural institutions, children's centers "Barkamol avlod", music and art schools, including in remote and rural areas;
- educating a physically and spiritually healthy young generation, creation of favorable conditions for the regular participation of children and youth in a wide range of sports, as well as facilitating the participation of schoolchildren in international competitions, the restoration of national sports;
- establishing a specific system of categorized and individual payments for social services, including utilities, that is, the introduction of rules based on solvency, profession and social status of the payers;
- a further increase in the number of schools with in-depth teaching of the exact and natural sciences, support for the successful participation of students in international scientific Olympic chempionships.

4.2. In the field of strengthening the institution of the family and family values in society:

- establishing of scientific legal measures aimed at ensuring the existence of strong families in society, a sharp reduction and prevention of family divorces;
- promoting and strengthening family traditions and values, such as family solidarity, respect for older people and caring for children;
- strengthening the morality inherent in the Uzbek family, and, conversely, strengthening the role of the family in the fight against various harmful influences from the outside that are not inherent in our national mentality, solving the spiritual and legal problems of the family, increasing medical literacy and culture, accelerating educational work aimed at a stable image life, reproductive health;
- strengthening care for young families, ensuring their social and legal protection, an even greater increase in the number of healthy and strong families in order to bring a healthy and intelligent generation to the world;
- the implementation of initiatives aimed at eliminating the unpleasant situations that still remain in the lives of families, in particular, holding wedding ceremonies with extreme luxury and other events based on excessive wastefulness;
- carrying out propaganda activities related to the education of youth in traditional family life, with the adoption of interpersonal relations in the family at the level of family values;
- introducing flexible intervals in working hours for citizens, especially women, to create conditions for females to spend more time in the family.

4.3. In the field of strengthening social protection with an emphasis on gender characteristics:

- conducting systematic approach to create and develop the necessary conditions for women to do needlework, housekeeping, craftsmanship, and parenting;
 - introducing a constructive system to solve social problems of females
- systematic effort on social rehabilitation and protection of women and girls released from prison;
- assistance in creating the necessary conditions for the adaptation of women and men returning to their homeland from abroad, who have been there for a long time for certain reasons:
- protecting the interests of women and their children who have lost their homes as a result of divorce;
- establishing equal responsibility of men and women in order to get full employment of young families;
- timely identification of women's problems, support for women who need help and have a difficult social situation;
- extensive cooperation in order to attract and support women and young girls in rural areas to family and private entrepreneurship and craftsmanship;
- creating a system of individual work with men and women to improve the socio-spiritual environment in families;
- eliminating gender inequality and reflecting gender equality in all areas of professional training in the concept of development of higher education institutions based on the principle of global cooperation in the field of education;
- organizing career guidance for students before entering a higher educational institution, the introduction of measures for girls in STEM (Science, Technology, Engineering and Mathematics), training in subjects orientating to the teaching profession for boys and stimulating them to work in these areas in the future;
- attracting males to the education system as teachers in order to provide gender balance in teaching staff in schools;
- assistance in planning and organizing mass physical-sports events, treatment in sanatoriums for women and children.

4.4. In the field of further improvements in the Mahalla system, strengthening its organizational and economic foundations:

- petting limits on non-specific tasks given by superior bodies to Mahalla organizations, strengthening their material and technical base, strengthening their independence, increasing the effectiveness of the Mahalla, especially in the field of

preserving and developing customs, traditions and values, creating a healthy environment in the family;

- organizing activities of the Mahalla institution, which will ensure wide participation of citizens in restoration and development of national and spiritual customs, traditions and values;
- increasing the efficiency of Mahalla's activities in solving issues related to the spiritual and moral education of citizens, youth, improving the efficiency of work in the social sphere, improving public safety and law enforcement in the field, intensifying efforts related to strengthening public control over the activities of governing bodies;
- reviewing financial system of the Mahalla institution, including chairman of the Mahalla (Oqsaqol) and its members, ensuring their independence from local government, establishing a Mahalla as an administrative-territorial unit.

4.5. In the field of reforming the system of science and education, gradually increasing the coverage of the population of our country with higher education by 50 percent:

- supporting to increase the number of more than 110 higher education institutions and their branches in our country to 150 units in accordance with the scientific potential, material and technical base;
- promoting the doubling of the number of teachers in the Doctors of Philosophy (PhD) and Doctors of Sciences (DSc) in our country by simplifying the procedure for obtaining degrees of Doctor of Philosophy (PhD) and Doctor of Science (DSc);
- integration into the world educational and scientific community, expanding the training of specialists by teaching core subjects only in higher educational institutions;
- creating a system for the constant translation of foreign scientific and practical literature into the state language, simplifying of obtaining academic degrees and qualifications, increasing the quantity and quality of specialized scientific councils, introducing payment system to their members;
- expanding access to higher education on a fee-contract basis, introducing modern perspective achievements of science into the educational process, further developing science in our country, promoting the formation of a highly qualified society by attracting talented, gifted youth to scientific activities;
- introducing online and part-time types of studies, supporting higher education institutions to be totally independent;
- reforming admission system for master degree, abolishing subjective approaches to the admission process;

- increasing coverage for postgraduate education, in particular, increasing quotas for admission to basic doctoral studies;
- establishing general control over the conformity of education and upbringing with our national values, moral criteria in private educational institutions, especially in private preschool educational organizations and schools;
- improving the system of training qualified personnel in accordance with current and future needs of the labor market;
- establishing international standards in the field of education quality assessment and training;
- strengthening the material and technical base of educational institutions in the villages;
- organizing scientific and practical specialized laboratories, high technology centers, technological parks at higher educational institutions and scientific-practical research institutes;
- creating effective ways of introducing scientific and innovative achievements into practice;
- expanding the network of pre-school educational institutions and radically improving the conditions for the comprehensive, aesthetic and physical development of children in these institutions, increasing the level of coverage of children in kindergartens, and improving the qualifications of teachers and specialists;
- reforming criteria for the selection and training of teaching staff. In this direction, psychological tests and creative exams are needed to be introduced. Opening faculties of "upbringing methods in the pre-school period" and "Organizing educational affairs at school" into the higher education system;
- supporting for the opening of special courses of "School of Young Parents" and "Educational affairs in the Family" aimed at preparing parents and children for public life, as well as preschool education;
- the full achievement of "Science Education Production Integration of Innovation", maximizing a number of teachers at universities who obtained experience and qualifications in the related fields;
- providing conditions to the realization of the creative potential of youth through the implementation of educational measures aimed at ensuring the safety of the educational environment and the prevention of corruption;
- further improvement of electronic educational resources in kindergartens, schools, secondary special and higher education, as well as providing access to local and world electronic educational resources;

- raising the status of teachers, providing social protection, creating comfortable working conditions for them, eliminating unnecessary paperwork and formalities.

V. Priority areas in the implementation of foreign policy, security, inter-ethnic harmony and religious tolerance

"FOREIGN POLICY BASED ON NATIONAL INTERESTS IS THE BASIS OF PEACE AND STABILITY"

The party advocates that the foreign policy of the Republic of Uzbekistan be based on such principles as the priority of the interests of national statehood, non-interference into the internal affairs of other states, peaceful settlement of all conflict issues, equality of states, non-use of force or prevention of a military threat, inviolability of borders and strict observance of others principles of international law.

The party considers its priority to promote the cultural, traditional and national spiritual values of the nation of Uzbekistan in the world, which are considered to be an integral part of the world. As well as, further increase in the prestige of Uzbekistan as a country of great scientists and scholars in an international sphere.

The party considers it important to develop appropriate programs to familiarize the world community with the achievements of Uzbekistan in the sociopolitical, socio-economic, cultural and spiritual spheres, including usage of the capabilities of influential national and international media.

The party pays special attention to the field of inter-ethnic relations in our country. One of the important priorities of state policy is the promotion of tolerance and humanism, the strengthening of interethnic and interfaith solidarity, the consent of citizens in society, the creation of equal rights and opportunities for all citizens regardless of nationality and religion, the patriotism of the younger generation, respect for national and international values, and upbringing young people being allegiance to the motherland.

The party consistently continues to integrate the idea of "Uzbekistan is our common home" to strengthen the idea of a single multinational family in the minds of citizens regardless of their nationality and religion.

The party will promote initiatives for the systematic implementation of national and international projects, cultural, educational, scientific and economic events, which will enhance the positive image of Uzbekistan.

We will choose a reasonable compromise with all the countries of the Central Asian region on all issues without exception, in particular, our party emphasizes the need for an approach that takes into account the interests of the countries of the region on water resources in cooperation with UN. It supports all constructive efforts aimed at eliminating environmental problems in the region.

Since terrorism today poses a real threat to the world community, it is necessary to improve state programs aimed at protecting young people from their negative impact, taking into account the real situation.

The party advocates an active foreign policy aimed at promoting economic integration and protecting national interests, efforts to establish inter-confessional, cultural dialogue.

5.1. In the field of developing an active and mutually beneficial foreign policy:

- continuous protection of national interests, prevention of one-sided or many-sided cooperation against the interests of Uzbekistan and not beneficial for our nation;
- -wide promotion of the achievements of the people of Uzbekistan on the basis of many years of statehood, culture and art, strengthening the positive image of Uzbekistan in the international sphere;
 - providing effective protection against information attacks by other states;
- wide diversification of economic, technological, transport and other ties with the goal of reducing Uzbekistan's dependence on some partners and other countries;
- strengthening the international image of our country as a reliable, responsible partner in the political, trade and economic spheres;
- supporting initiatives to develop many-sided relations with Afghanistan, which is our close neighbor, to restore historical and cultural ties, establish regular contacts between writers, people of art and youth, and therefore, contribute to peaceful environment in Afghanistan;
- strengthening international relations for further cooperation based on friendship and mutual trust with neighboring countries;
- compliance with generally recognized norms of international law in the field of foreign policy and the protection of national interests.

5.2. In the field of protecting the rights and legitimate interests of legal entities and our compatriots living or carrying out activities outside the Republic of Uzbekistan:

- strengthening the principle that citizens of our country are protected by Uzbekistan and its diplomatic services, regardless of where they are, as well as acceding to international conventions related to this field;
- close communication and effective cooperation with the Uzbek people in foreign countries;

- establishing permanent relations with our compatriots living and studying abroad, protection of their rights and legitimate interests;
- providing our compatriots with reliable legal information about legal residence and work in foreign countries, organizing specialized legal consultations;
- putting forward an initiative to open new embassies, consular services and representative offices of Uzbekistan in foreign countries, as well as expanding their authority and ability to protect the rights of our compatriots, at the same time, increasing their responsibility;
- organizing various cultural and educational events in foreign countries in order to maintain the loyalty of our compatriots to our national culture, spirituality, religion, traditions, customs and values;
- introducing a regular reporting system of the Ministry of Foreign Affairs, the Agency for External Labor Migration, the Ministry of Internal Affairs and other responsible organizations in front of the chambers of the Oliy Majlis on the state of protection of the rights and interests of our compatriots.

5.3. In the field of preserving the national gene pool, ensuring food security and occupying a worthy place in the world market:

- further preservation of the nation's gene pool, ensuring food security, expanding the diversity of nutrition of the population;
- popularizing physical culture and sports in order to preserve the nation's gene pool, the creation of conditions for physical education in pre-school educational institutions and schools, an increase in the number of specialized sports schools, increased selection affairs for sports schools among high school students:
- increasing the production of high-quality and safe food products in our country, the maximum restriction on the use of genetic modification methods;
- preventing prices from sharp increase in for food products in cities and villages of the country, implementation of initiatives to ensure the reasonable prices for food products with the solvency of the population;
- taking measures to increase demand for Uzbek products in the international market;
- constant monitoring of the activity of international markets, providing timely information to our farmers and local producers;
- taking measures to ensure access of Uzbek products—"MadeinUzbekistan"—to the world market;
- creating conditions for close cooperations between logistics organizations of Uzbekistan and international logistics organizations;

- creating a system of stimulation for the activities of suppliers of agricultural food products;
- providing government support for the development of livestock, poultry, beekeeping and fish farming.

5.4. In the field of ensuring inter-ethnic harmony and religious tolerance:

- taking measures to strengthen the free, peaceful and self-sufficient life of the people of Uzbekistan and all citizens, regardless of their nationality, language, religion and social origin;
- uniting people for the feelings of international respect, friendship and solidarity, patriotism, responsibility;
- working in collaboration with the Center of Islamic Civilization and the Islamic Academy under the Cabinet of Ministers of the Republic of Uzbekistan on issues of inter-ethnic relations and friendly relations with foreign countries;
- practical implementation of the resolution "Education and religious tolerance" put forward by Uzbekistan and adopted by the UN General Assembly;
- propagating ideas of humanity of the sacred Islam religion under the slogan of "Enlightenment against ignorance and violence", propagating Islam;
- -supporting careful and respectful attitude to our sacred religion, which embodied our ancient values and moral qualities;
- -studying, deep understanding and widespread popularizing the works of scholars of the Islamic world, our great ancestors, their multifaceted religious and spiritual heritage, and invaluable contribution to the development of world civilization.

5.5. In the field of solving the most important tasks of the Unified Foreign Economic Policy, aimed at implementing the idea of national development:

- increasing the reputation and positive image of Uzbekistan as a reliable, responsible political, trade and economic partner in the world community;
- active promotion of Uzbekistan's international initiatives in the field of security, political, diplomatic, trade, economic, transport and communication, cultural and humanitarian and other fields, as well as the country's position and approaches in regional and global development;
- creating favorable conditions for expanding the participation of Uzbek businesses in foreign markets, ensuring the participation of local companies in the system of international production cooperations;
- using widely the attractiveness of Uzbekistan the widespread use of folk culture, art, traditions, customs, values, and a way of life in order to achieve strategic goals in foreign policy, foreign economic environmen;

- expanding cultural and humanitarian ties with foreign countries and international organizations, propagating and preserving the cultural, historical and spiritual heritage of our people, providing a broad demonstration of the achievements of Uzbek culture and science abroad.

5.6. In the field of further development of international relations:

- supporting for the policy to restore the Great Silk Road which united Ancient East and West, which plays an important role in institutional strengthening and establishing cooperation in the political, economic, cultural and humanitarian spheres, promoting the brand of the Great Silk Road;
- reasonable and equitable use of water resources of transboundary rivers of Central Asia, taking into account the interests of all countries of the region, as well as international legal norms the UN Convention on the Protection and Use of Transboundary Watercourses and International Lakes (Helsinki, 1992) and the UN Convention on the Law of Non-Navigational Uses of International watercourses (New York, 1997);
- formulating measures to enhance and develop "people's diplomacy" in international relations, in particular, the activities of the Committee of the interethnic relations and friendly cooperation with foreign countries under the Cabinet of Ministers of the Republic of Uzbekistan to strengthen friendship and cooperation with the peoples of the world, our compatriots living abroad, as well as familiarizing the public of foreign countries with the history and culture of our country;
- working on strengthening of ties with the International Olympic Committee with the aim of including the Uzbek wrestling Kurash among the Olympic Games, based on our national values, perseverance, courage, patriotism;
- further cooperation with international organizations promoting the rich cultural and historical heritage of Uzbekistan, including UNESCO and the World Intellectual Property Organization.

VI. PRIORITY AREAS IN THE SPIRITUAL SPHERE.

"WHEN HUMAN CHANGES, SOCIETY WILL CHANGE"

The party considers it important to deepen reforms in the spiritual and educational sphere in order to strengthen the feeling of national identity, feelings of national pride and dignity among our compatriots.

Uzbekistan is the birthplace of great scientists and scholars, one of the cradles of world civilization, an integral part of the world material and intangible heritage, a center of spirituality and enlightenment, a country with high intellectual potential.

The party believes that through the implementation and restoration of national identity, the preservation and development of the spiritual and educational environment in society, it is possible to successfully solve the challenges that we face in the political, legal, socio-economic and other fields.

National identity plays an important role in the development of our country, is an invaluable internal factor in the formation of feelings of love for the country and in educating a perfect person.

National identity, the origins of the human kind begins with a study of history. A nation that has not mastered the historical experience of developing its own national statehood, national culture and spirituality is not capable of national revival.

The Democratic Party of Uzbekistan "Milliy tiktanish" considers that it is necessary for the further development of our Motherland to have a competitive and stable economy, a strong spiritual foundation, and national identity.

The party considers as a priority direction of its activity an active participation in the process of national-spiritual revival and prosperity, ensuring the priority of the principles of our national idea, strengthening the moral and spiritual foundations of our society, and further deepening reforms in the spiritual and educational sphere.

We believe that an important task is to preserve national identity based on sacred traditions, customs and values that have been shaped by our people for centuries. Our vision, goals and objectives are devoid of any nationalistic ideas.

Raising national spirituality based on the rich spiritual heritage of our ancestors and introducing it on a global scale is the priority idea of our party.

6.1. In the field of development of national culture and spirituality, preservation and enrichment of national traditions, customs and values:

- the preservation, enrichment and promotion of the historical, cultural and scientific heritage of our people, the study of the rich history and culture of the Uzbek people, their wide propaganda among the younger generation, the education of young people in deep respect for the historical heritage and folk traditions;
- developing and implementing the projects based on the promotion of national characteristics such as mercy, hospitality, generosity, mutual respect, tolerance, kindness and generosity inherent in our people;
- ensuring a deep, comprehensive and consistent study of the history of Uzbekistan, consistent observance of the principles of historicity and impartiality in this regard, the fight against distortion, falsification and misinterpretation of the history of Uzbekistan and the current life of the Uzbek people, bringing reliable facts about the historical past of Uzbekistan to the international auditory;
- widespread propaganda of the achievements of culture and art of the people of Uzbekistan in the international arena, the creation of works of cinema dedicated to the life and work of scientists, culture, literature and art, great statesmen, military leaders who lived on the land of modern Uzbekistan and made a significant contribution to the development of world civilization and culture;
- restoration and development of national types of crafts, which over the centuries have acquired high aesthetic value, preservation of the traditions of ancient schools of art crafts, separating the status of craftsmanship from entrepreneurship;
- learning the history of national clothes and dresses deeply, the popularization of national clothes and dresses, the expansion of their use in practice;
- the development of the carpet-weaving school, the organization of the National Association of Uzbek Carpet-weavers, the creation of the Uzbek Museum of Carpet-weaving, the organization of carpet-weaving enterprises based on the choice in each district and city, the creation of an online catalogUzbekgilam.uz;
- establishing funds aimed at studying the social, economic, political, legal, cultural history of the people of Uzbekistan.

6.2. In the field of protecting youth from the negative impact of "global culture", which is harmful to the consciousness of young people and the new generation of our nation:

- educating youth in the spirit of national revival and prosperity, respect for national culture and values;

- organizing exhibitions and conferences, radio and television programs aimed at increasing the influence of scholars of national and spiritual revival, establishing spiritual and educational centers and developing their activities, increasing the fund of the Alisher Navoi National Library, the wide involvement of young people in the libraries:

-educating the younger generation, primarily in the spirit of love and respect for the book, increasing their interest in paper materials, encouraging printing and publishing centers on economic basis engaged in the publication of literature on the history, spiritual and cultural heritage of the nation of Uzbekistan;

- organizing public visits by students of educational institutions to cultural and historical places of our country, the organization of open days in theaters and cinemas, the provision of youth visits to exhibitions that provide information on the history and culture of Uzbekistan;
- developing the spiritual and cultural level of children, creating favorable conditions for them to be associated with the best arts of domestic and world musical culture, promoting the participation of our youth in international prestigious competitions and celebrations and supporting for winning prizes;
- protecting young people from the negative impact of "global culture", contrary to the mentality of our people, information that could harm their spiritual and moral formation, values, life and health;
- advocacy within the framework of the concept "Enlightenment against ignorance and violence", aimed at strengthening the principles of the traditional Islamic religion in society, especially among young people;
- creating a system of specialized pedagogical, psychological and medical expertise regarding the impact of various types of food and non-food products produced for children on their health, upbringing, and spiritual level;
- taking measures to stimulate the production of historical, popular films, cartoons for children, devoted to the rich history of Uzbekistan, great scientists, the life of scholars and politicians.

6.3. In the field of study and promotion of national, scientific and historical culture and their sources:

- learning scientific, philosophical, spiritual, moral, educational poems and handwritings of our great ancestors, putting forward an initiative to translate them into modern Uzbek language;
- facilitating the publication, promotion and popularization of these writings at the national and international levels;
- improving the material and spiritual support of researchers who are conducting research based on rare resources and ancient manuscripts;

- establishing Maqom schools, maintaining Bakhshi, Lapar, Askiya, national games of Kurash, Kupkari, Chavgon and other national values, which are considered unique examples of folk art based on the traditions of "ustoz shogird" ("teacher apprentice"), taking measures to expand propaganda and public participation in this processes;
- launching libraries in mahallas in order to develop a culture of reading among our people on the basis of public-private partnerships, especially in remote villages, the adoption of measures to enrich their collection with artistic, historical, scientific and popular literature;
- paying special attention to ensuring adequate funding system for science, culture and education in Uzbekistan, encouraging representatives of these areas;
- propagating our rich history, national identity and values through theater, cinema and music;
- the creation of feature, fiction, journalism, documentaries, national series and animated films reflecting national values, traditions, historical stages of development of Uzbekistan as a state, as well as improving the system of state financing to create images that reflect the great figures of our history;
- putting forward an initiative to improve legislation on the media, television, radio and social networks, aimed at preventing broadcasts that promote "global culture" and affect negatively our national culture and generations;
- reforming our national values and traditions on the basis of a full inventory, their division will be as follows; "endangered national values and traditions, currently in need of restoration,", "currently popular traditions that contradict our national values and traditions", "national values and traditions that must be steadily maintained";
- stimulating and expanding the Institute of Oriental Studies named after Abu Rayhon Beruni, where rare works and manuscripts are being stored and learned, stimulating the transfer of public and private funds to the university activities;

- identifying the burial places of our great scientists who had made a great contribution to world civilization outside the territory of Uzbekistan, improving their graves and tombs, as well as arranging their symbolic tombs in the regions of our country (Abu Rayhon Beruni in Ghazna, Zakhiriddin Muhammad Babur in Kabul, Alouddin Ali ibn Muhammad al-Kushchi in Istanbul, Jalaliddin Manguberdi in Tunzheli, Alisher Navoi, Lutfiy, Kamoliddin, Behzod Hussein Baykaryo in Gerate in Afganistan).

VII. Priority areas for the protection of cultural heritage and tourism development

"TURNING PRESERVING THE CULTURAL HERITAGE AND TOURISM DEVELOPMENT INTO NATIONAL MOVEMENT"

The party works to protect the historical appearance of the ancient cities and villages of Uzbekistan, to improve legislative standards for the preservation and restoration of historical places, architectural monuments, which are the cultural heritage of all humanity. In particular, it is necessary to restore the Institute for the Restoration of Cultural Heritage under the Ministry of Culture, reforming the funding system for archaeological research and the Institute of Archeology, developing specific measures for social and material support for scientific and technical personnel working in this field.

Our main goal is to strengthen the position of the tourism sector as a strategic network of the national economy, increase the positive image of the country by popularizing tourism and investment potential, history and culture in the world, recognizing our country as a touristic destination.

7.1. In the field of protection and rational use of cultural heritage objects:

- implementing effective measures to preserve the existing cultural heritage sites in our country, preserving the historical appearance of the cities of Uzbekistan;
- support for the creation of a map of the cultural heritage of Central Asia, including the historical and famous cities of Central Asia;
- completing the process of making the electronic list, state document representing location of objects of cultural heritage, as well as strengthening state protection and designating the boundaries of protection, implementing legislative initiatives to prevent their disappearance or destruction;
- establishing permanent parliamentary and public control over the conservation, restoration, preservation and restoration of cultural heritage in Uzbekistan;
- developing a museum science in our country, strengthening the material and technical base of existing museums based on modern and advanced innovative technologies, enriching their material resources and expanding the infrastructure of museums;
- support for the creation of the "Portal of cultural heritage of Uzbekistan" the organizer of an electronic database of all cultural heritage sites;

- identifying and conducting research of ancient manuscripts, books and other antiquated objects related to the history and culture of our country, stored in foreign countries, accelerating the activities intended to return them to our country.

7.2. In the field of cardinal improvement of the legal framework for the protection of cultural heritage:

- increasing the number of objects of tangible cultural heritage from more than eight thousand to ten by identifying new objects; acting as the initiator of these actions;
- establishment and expansion of permanent parliamentary, deputy and public control over the storage and use of cultural heritage objects;
- developing a general list of objects of cultural heritage located in museums, archives, libraries and other places of storage, as well as the procedure for their registration, storage and use;
- investigating into cultural heritage sites, social protection of workers involved in the preservation of cultural heritage sites, along with material support to increase their knowledge and potential;
- continuous monitoring of the safety of cultural heritage objects, including those used for free or rented, in accordance with the law;
- preparation of cadastral documents of objects of tangible cultural heritage, withdrawal of land plots on which objects are located from economic turnover, strengthening of state security and designation of the boundaries of protection of protected lands;
- prevention of damage to objects of tangible cultural heritage and their protection from external influences (precipitation, wind, salinity, groundwater, earthquakes, vibrations that occur when vehicles move due to the proximity of roads, etc.);
- increasing funds annually allocated from the budget of the republic for the conservation, restoration and restoration of cultural heritage objects, ensuring the attraction of local budget funds;
- improving legislation on the procedure for the seizure and import of cultural property;
- support for the development of management plans for historical cities included in the UNESCO World Heritage List, initiatives to include our cultural heritage into the UNESCO World Heritage List, in the Representative List of the Intangible Cultural Heritage of Humanity, as well as the World Memory List.

7.3. In the field of tourism development as a strategic sector of the economy and a factor in increasing the image of the motherland:

- implementing strategic initiatives aimed at turning our country into one of the world tourist centers, and tourism into a nationwide movement;
- making initiatives for "low-cost airlines" low-cost flights, as well as an increase in a number of flights from foreign countries increases flow of tourists into our country is high; implementing initiatives to create a healthy competitive environment in the industry;
- promoting the development of domestic tourism, in particular, the involvement of schoolchildren, retirees, employees of organizations and institutions in domestic tourism:
- further improvement of tourism infrastructure, the development of rural tourism, the creation and development of comprehensively acceptable conditions for tourists, in particular, these are convenient, inexpensive transport and hotel services, ensuring the introduction of modern information technologies into the sphere;
- improving the quality of services and services on tourist routes, international airports, railway stations;
- taking measures aimed at eliminating existing administrative barriers in the sphere, formalities for foreign and local tourists, simplifying the processes associated with the registration of foreign tourists, as well as providing road transport for tourists;
- continuation of the state visa policy aimed at simplifying the visa issuance procedure, aimed at citizens arriving from countries that have established long-term strategic partnerships with us and have a stable tourism market, in this regard, the introduction of interactive state services in the field of mutual exchange of visas;
- establishing control of parliamentarians, deputy of local Councils, and public control over ensuring the timely and full implementation of the Law "On Tourism", secondary laws, and also state programs.

- launching the online platform "Qualitycontrolling" to effectively manage the quality of service of tourism infrastructure facilities;
- the formation of a targeting strategy for the promotion of commercial information about the national tourism products;
- organizing "competition of creative" in order to ensure the attractiveness of advertising of touristic brands of the regions;
- using all the possibilities of social media resources in promoting the national tourism products in foreign markets;
- using the analysis "Revenue management" to expand the geography of export of tourism services in Uzbekistan.

- widespread implementation of the project "Every Family is an Entrepreneur" in the tourism sector.

- focusing on the widespread use of the Internet, non-traditional marketing methods in the promotion of tourism products (popularizing holidays, organizing information centers in foreign countries, etc.).

7.7. In the field of training and retraining of qualified personnel for the tourism sector and improving the system of advanced training of subjects of the sphere:

- further reforming the training system, the introduction of a national vocational education system (training, retraining, advanced training) that meets the requirements of international standards;
- -introducing modern innovative educational standards in the field of tourism education, attracting highly qualified foreign specialists;
- -launching branches of leading international higher education institutions that educate specialists in the field of tourism in Uzbekistan.
